For everyone interested in exploring how to make the island's visitor industry more sustainable and environmentally friendly, KPAA is hosting a one-day conference on *Greening Kaua`i's Visitor Industry*. The conference will be Thursday, November 9<sup>th</sup> from 8:30 a.m. to 5:30 p.m. at the Sheraton Kauai Resort. Information on green business practices in Europe, New Zealand and other parts of the world, as well as resources and technical assistance available to companies right here in Hawaii will be presented. Local businesses that have integrated energy and water efficiency, waste management practices, and green products into their day-to-day operations will share their experiences. Early registration cost is \$50 and just \$35 for additional participants from the same company. The last day to register is November 6<sup>th</sup>. ### **Telephone Survey for Community Indicators Project Begins**

Work on the *Measuring What Matters for Kaua`i* community indicators project is well underway. Next week, a telephone survey will begin to find out what many of our residents feel about quality of life issues on the island. So if you receive a telephone call, please take a few minutes to respond to the survey! The results will be combined with data on other important island issues and incorporated into a report to be published later this year. The report will provide a snapshot of how the island is doing in a variety of areas, including economy, education, natural environment, land use and rural character, neighborhood and community well-being, health and wellness, public safety, civic engagement, and cultures and arts. The report will help us determine Kaua`i’s progress toward achieving the community vision in the *General Plan 2000*.

### **Sustainability is Hot Topic**

About 150 Kaua`i residents showed their support for Kauai’s sustainability at a meeting last week organized by the Hawai`i 2050 Task Force. KPAA lead the community discussion portion of the meeting. This is part of a statewide dialogue of what sustainability means within our state. Kaua`i organizations, groups and government agencies are also actively pursuing strategies and projects to promote sustainability in areas as diverse as diversified agriculture, energy efficiency, environmental protection, land use management, and perpetuation of Native Hawaiian culture. ### **Upcoming Training for Kaua`i Nonprofits**

*Fundraising on Kaua`i*: Kim Klein, internationally known fundraising trainer, consultant and founder/co-publisher of the *Grassroots Fundraising Journal* will be on Kaua`i Monday, November 13<sup>th</sup> to present a special workshop. *Fundraising on Kaua`i* is designed to take into consideration the unique fundraising challenges on Kaua`i. The workshop is sponsored by the Hawai`i Community Foundation. It will be held at the Aloha Beach Resort; registration fee is \$60.00 per person. The Hawai'i Alliance of Nonprofit Organizations (HANO) is bringing two of its Essential Nonprofit Know-how workshops to Kaua'i on November 17<sup>th</sup>. Both workshops will be held at the Kaua'i Humane Society in Puhi.

*Critical Issues for Nonprofits: The Legal & Financial Environment* - This workshop highlights recent changes in the national and local legal environment that will affect Hawai'i nonprofits, such as risk management and directors and officers insurance, the IRS Form 990, Sarbanes-Oxley, and the Hawai'i Nonprofit Corporations Act. It provides board members, executive directors, financial managers and bookkeepers guidelines for developing your organization's policies and procedures, improving oversight and establishing critical internal controls. Presenters are Allen Arakaki, CPA, and Brian Ezuka, an attorney specializing in nonprofit law. This workshop is from 8 a.m. to 12:30 p.m. Cost is \$65 per person for HANO member organizations and United Way agencies, \$110 for non-members.

*Business Planning for Nonprofits: An Overview* - This workshop is designed to cover the basic elements of a nonprofit Business Plan. It will help board members and staff to decide when a Business Plan is needed and whether an organization should initiate business planning activities on its own and when to seek assistance. Topics covered include: Financial Projection Basics, Business Risks and the Frame of Mind Needed for Successful Business Planning, and What to Prepare Before You Seek Assistance. The presenter is James Koshiba of 3Point. This workshop is from 1:30 to 4:30 p.m. Cost is \$60 per person for HANO member organizations and United Way agencies, \$90 for non-members.
