Drug Action Team Update

Developing the Anti-Drug Action Plan: KPAA is working with Roy Nishida, the County's Drug Coordinator, to facilitate development of an anti-drug plan and launch the implementation of the plan's activities. Four committees, whose initial participants were appointed by Mayor Bryan Baptiste, are meeting to tackle specific areas that will be included in the island-wide drug plan – Prevention, Enforcement, Treatment and Community Integration. Each committee has a liaison to the **Drug Action Team**, which meets to coordinate the work taking place within the committees. Our goal is to complete preparation of a five-year plan and two-year action plan by April 2004, and then to begin implementing the action plan activities.

County and KPAA Hosted November 8 Drug Planning Forum: About 150 people recently spent a Saturday at the Coconut Beach Resort learning about the impacts of illegal drug use on Kaua'i and steps being taken to mitigate the problem. Participants also developed a vision statement of Kaua'i in five years – a vision of what we could achieve by alleviating drugs on our island.

Mayor Bryan Baptiste welcomed forum participants and asked for broad community participation in the war against drugs. Lieutenant Governor Duke Aiona discussed the State's efforts to address the drug problem, acknowledged the work of the Baptiste administration, and stressed the need for ongoing county/state coordination. U.S. Attorney Ed Kubo discussed the need for affordable drug treatment, longer medical insurance coverage for treatment, more drug prevention education targeted to at-risk youth, and, for those not at risk, drug education and awareness classes with a message tailored to the age of the child. In the area of enforcement, he stated efforts should focus on stopping the importation of ice, changing the State Constitution to bring back the "walk and talk" program, and changing the State wire tap law to make it consistent with federal law. Sherry Wong, Director of Training, Prevention Science Group, Channing Bete Company, described the Communities That Care (CTC) System. CTC is based on successful public health models that target predictors of problems specific to a community. It is a data-driven, research-based approach to promote positive development of children and youth. Shawn Cremer and Christina Aki described their experiences of drug addiction to recovery, and stressed the need for on-island treatment services. Senator Daniel K. Inouye announced that the Omnibus Bill now before Congress includes \$1.2 million to support Kaua'i's anti-drug efforts.

And we seek to uncover a base of shared meaning that can greatly help coordinate and align our actions with our values.
