Reflections on 2010

In recent weeks I've heard a number of people say how glad they are this year is almost over.

Kalalau Trail Project Complete



The trail along the first two miles of the Napali coast is now in better condition than it has been for years, thanks to 14 months of trail rehabilitation work. The photos before (left) and after (right) show some of the significant improvements. This came about because the 2007 legislature approved a grant-in-aid to KPAA through the Hawaii Department of Land and Natural Resources to reconstruct major portions of the trail from Kee Beach to Hanakapiai Beach. KPAA selected the team of Pono Pacific Ecosystem Restoration Services and Native Hawaiian Conservation and Hiking Expeditions ("NHCHE") to manage and perform the trail rehabilitation.

As a trail specialist in the field of conservation, team leader Charlie Cobb-Adams and his crew

used techniques designed for severely eroded trail systems. All the trail building was approached from an environmentally-friendly perspective. Each trail feature worked on was to increase public safety. All the improvements were intended to have a rustic appearance as appropriate in this special wilderness park. Fortyfour (44) volunteers, working with the Friends of Kalalau Trail



under the supervision of Cobb-Adams, have put in about a thousand hours learning how to maintain and steward trails. Don't Forget Your Shopping Bag!

The County of Kauai has adopted Plastic Bag Reduction Ordinance No. 885 to go into effect January 11, 2011 to reduce the significant impacts of plastic checkout bags on the environment. The law requires establishments to provide only recyclable paper bags and reusable or biodegradable bags to customers, and all bags distributed must comply with the law's definition of these bag types.

The law encourages customers to bring their own reusable bags while shopping. Retailers can offer checkout bags for sale to those customers who do not bring their own bags.
