KPAA Annual Meeting June 30



Plan to attend KPAA's annual meeting on Thursday, June 30 from 3:30-5:30 PM in KCC's Fine Dining Room. Following a short membership meeting and update on KPAA projects, the guest speaker will be Leslie Wilcox, President and CEO of PBS Hawaii since 2007 and a former broadcast and print journalist. "Can Do!" will be the theme of her presentation, which aptly describes how she has tackled her role at PBS Hawaii, where she is a television host in front of the camera as well as the chief executive. Among her many tasks is ensuring that programming and educational services meet the evolving needs and interests of PBS Hawai'i's viewers and that the nonprofit organization continues to earn the public's trust and financial support. "Can Do" is the translation of an exciting first-year program called HIKI NŌ, the nation's first statewide student news network. If you are a KIUC customer, you should receive information and a ballot to vote on whether you support the KIUC board's decision to explore hydroelectric projects on six streams on Kauai in collaboration with Free Flow Power (FFP), which has applied for permits through the Federal Energy Regulatory Commission (FERC). Ballots must be submitted by July 8.
